

## **Financial Assistance Program**

Boone County Hospital is committed to providing financial assistance to persons who have healthcare needs and are uninsured, underinsured, ineligible for a government program, or otherwise unable to pay, for medically necessary care based on their individual financial situation. Financial assistance will be available only to residents of Boone County, or the immediate surrounding service area consistent with its mission to deliver compassionate, high quality, affordable healthcare services and to advocate for those who are poor and disenfranchised, Boone County Hospital strives to ensure that the financial capacity of people who need health care services does not prevent them from seeking or receiving care. Boone County Hospital will provide, without discrimination, care of emergency medical conditions to individuals regardless of their eligibility for government assistance.

## Financial Assistance Available to Those Who Qualify

Boone County Hospital has financial assistance available for those who qualify. Our financial assistance policy, a plain language summary and application are available on our website at boonehospital.com or may be obtained by mail by calling 515-433-8105. You need to complete an application and supply minimal financial information to establish your eligibility. We do offer financial assistance up to 400% of the Federal Poverty Income Guidelines. Patients eligible for financial assistance will not be charged more than the calculated amounts generally billed (AGB) by our organization. If you have any questions or need assistance to complete the application please contact our staff per the address and phone number below.

In order to qualify for assistance, you must:

- Complete entire application form; Hospital has staff available to assist if necessary.
- Provide a copy of most recent tax return, 3 months of bank statements, or two of the most current check stubs
- Provide documentation of at least one of the income sources listed on application.
- Provide evidence that you have pursued all other payment sources including public aid.
