

# Do Better By Doing Good

## ENDOWMENT CAMPAIGN

In 2014, the Boone County Hospital Foundation (BCHF) embarked on a "Do Better By Doing Good" Endowment Campaign that would assure the long-term vitality of Boone County Hospital (BCH) related to equipment, programs and services. To date, the community has contributed \$700,000 of the \$1 million cash goal and nine planned gifts via wills.

Boone County Hospital is an important asset to the county in several ways, including:

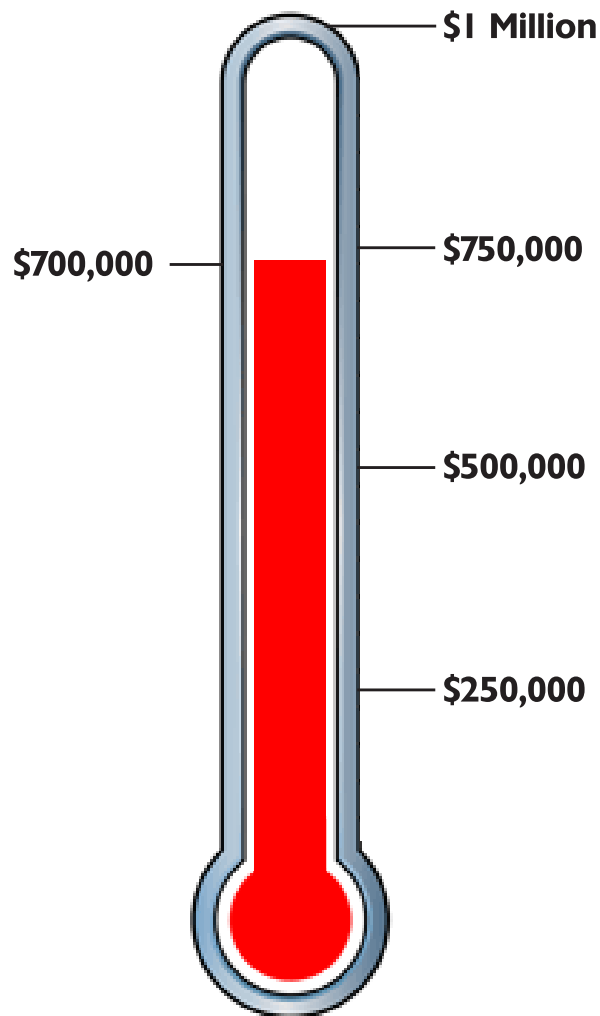
- It's the third largest employer in Boone County
- An annual payroll of over \$17 million
- An economic impact of over \$25 million
- Over \$554,892 was provided locally in charity care in fiscal year 2016.

With these endowment funds, the first project the Foundation is able to assist with is bringing 3D Mammography Genius Technology to BCH. With the help of the interest from the Endowment, private gifts and grants (listed below), the Foundation was able to contribute \$93,185 toward the project. *The 3D Mammography is slated to be implemented in the summer, 2017.*

## ENDOW IOWA TAX CREDITS

*The Boone County Hospital Foundation is a qualified foundation that provides access to Endow Iowa Tax Credits. The Endow Iowa Tax Credit Program allows taxpayers to receive a 25% Iowa tax credit, in addition to normal federal charitable income tax deductions.*

How it Works:

- A variety of gifts qualify for Endow Iowa Tax Credits including cash, real estate, farmland, appreciated securities and outright gifts of retirement assets.
- Endow Iowa Tax Credits are available on a first-come/first-serve basis until the yearly appropriated limit is reached. If the current year's tax credits have been exhausted, qualified donors are eligible for the next year's Endow Iowa Tax Credits.
- All qualified donors have five years to use their Endow Iowa Tax Credits.
- If you wish to receive the additional tax credit with your gift, please make checks payable to **BCH Foundation Endow IA Fund.**
